


HISTORY OF THE MARKET

- Located on Dakota Land by the Owamni Omni (St. Anthony Falls)
- Founded in 2006 by Brenda Langton in partnership with the Mill City Museum
- 115+ vendors, 6,500+ weekly visitors -summer market
- Market began as a 501(C4)
 Market, in 2017 added a 501(C3)
 Charitable Fund



WHAT MAKES US UNIQUE?

- Next Stage Grant Program (NSG)
- Hardship Grant Program



NEXT STAGE GRANT PROGRAM (NSG)

Providing funding to local, regenerative farmers and makers improving sustainable farming and business practices or growing toward the "next stage" of their business. Grants range from \$1,000 to \$7,000.



- Applications open by early January close on March 1st
- Funding received in April
- Over 100 grants funded so far
- Total of \$395,000 in grant funding

HARDSHIP GRANT PROGRAM

Intended to help alleviate small farmers' vulnerability to extreme weather-related crop loss or other unpredictable causes of hardship. Grants up to \$2,000.

- 10% of total yearly grant funds
- Applications open year-round while funding is still available
- Funding received within 6-8
 weeks after applying if approved



GRANT HISTORY



2013

MCFM farmer came to us with a hardship in the form of garlic blight, raised \$1500



2014

Raised more \$\$ and expanded to the Next Stage Grant for MCFM vendors



2017

Created Charitable Fund & formalized process, opening grant funding beyond MCFM vendors



2023

\$395,000 distributed to date funded through sponsorship & donations from annual benefit

WHY IT'S NEEDED

Creating more accessible funding to support farmers & our local food system

- Introduction to grant writing and process
- Easier application with 1-on-1 support
- Simple mid-season and final check-ins
- Can be used to leverage larger grants
- Available to makers as well as farmers
- Broader project scope with less strings attached



APPLICATION REQUIREMENTS



- Must sell at one or more regional farmers markets.
- Must be located within 200 miles of Minneapolis.
- Must adhere to MCFM's Sustainability Statement, or bring them closer to meeting it.
- Must have been in operation for over a year.
- Applicant must meet our Financial Need
 Statement OR project must demonstrate a significant research or education component.






